- Developed policy, procedures, and protocols for scheduling patients, saving data in Electronic Health Record (EHR), establishing workflow for psychometricians in the clinic, as well as managing, collecting, and reporting testing data for patients and providers.
- Instrumental in developing coding and reimbursement procedures for start-up of private practice clinic.
- Responsible for interviewing, hiring, and training three masters level psychometricians to handle high volume of testing referrals. Trained new psychometricians in EHR, clinic procedures, and on typical testing protocols for the clinic (i.e., NEPSY-II, WISC-V, D-KEFS, CAARS-2).
- Trained bachelor's level testing clinic assistant to do filing, data entry, and maintenance of confidential records for testing clinic.
- Streamlined the workflow of patients through the clinic including seeing providers and completing testing, reducing the time patients and providers had to wait for test completion and results.
- Worked closely with IT services to adjust the EHR to provide for better record keeping and billing of psychological testing procedures utilized in the clinic.
- Gathered referrals for psychological and neuropsychological testing from providers in a busy private practice with an in-house neuropsychological testing clinic under the supervision of licensed prescribing psychologist.
- Typical referrals ranged from learning disorders, trauma, mood disorders, TBI, diagnosis differentiation, and medication management concerns.
- Responsible for auditing patient files to ensure that all requested testing is completed, all data is processed and uploaded to EHR and made available to psychologist, all materials are

appropriately dated and labeled within EHR, and all testing procedures have been appropriately billed.

- Conducted feedback sessions with patients discussing results of the prescribed testing protocol upon conclusion of testing, data processing, and report writing. Patients were then scheduled with psychologist for follow-up regarding diagnosis, medication management, and treatment recommendations.

- Typical batteries included assessment of social, intellectual, neuropsychological, cognitive, achievement, personality functioning and review of records.
- Completed neuropsychological report writing under supervision. I wrote up test data, review of records, clinical interview, and summary sections. Participated in construction of discussion, diagnosis, and recommendation sections with licensed prescribing psychologist.
